Registration Fee Increases  
After January 1st

Application for the 40<sup>th</sup> annual Boogie on the Avenue in downtown Campbell. The dates of the show are **May 20<sup>th</sup> & 21<sup>st</sup>, 2017**.

Set up will begin at 7:00 AM on May 20th. Spaces will be held until 7:30 AM, after which time all spaces and fees will be forfeited. Show hours are from 9:30 AM to 6 PM Saturday and Sunday. Displays may remain up Saturday night, but no merchandise may be left, as you are responsible.

All items displayed must be original work, no mass-produced or imported arts or crafts will be allowed. Each artist must provide their own set up and display; including panels, tables, canopies, etc.. No mats or rugs are allowed. **PLEASE BRING YOUR OWN FIRE EXTINGUISHER as more city fire departments are requiring this as any tablecloths or coverings be flame retardant.**

There is a **\$285 registration fee, before January 1<sup>st</sup> 2017 after which the registration fee will increase to \$295** plus there is a **10% commission on all sales**. Exhibit spaces are approximately 10 feet wide and 10 feet deep. All entries must be received by May 15<sup>th</sup>, although all spaces may be filled before that time. Each exhibitor must have their own space; no two exhibitors may share the same space. If the show or your category is filled upon receipt of application, the entry fee will be refunded. Upon receiving your show form you will have up to 60 days before the show date to receive a credit for cancelling your space. There will be no credits given less than 60 days. All commissions will be due and payable between 5PM & 6PM Sunday night. Location of commission sight will be in your packet information that you will receive approximately 10 days before the event. Sorry, no rain refunds or postponements of the schedule date due to rain.

Please send separate checks for each show and now we accept credit cards (Visa/ Master Card/ Discover/ American Express). If you are charging your entry fees, they can be combined. You will receive a receipt with your confirmation. Returned checks are subject to a \$35 service charge. Make checks payable to: **CALIFORNIA ARTISTS**.
